<u>Bid Opening – Sand & Gravel Removal Lease Franchise</u>

One bid was received from Nugent Sand Company proposing a lease franchise for 5 years with the option to renew the lease for 3 additional terms of 5 years each. The lease would begin January 2024, a specific date to be determined by the Court. Nugent Sand would pay the County \$0.03/ton for sand and \$0.04/ton for gravel removed. There would be an annual minimum payment of \$5,000 per year for each lease year period. Magistrate Long made a motion to table the bid until the next meeting and Judge Wilhoite will speak to Nugent in regards to the royalties. Magistrate Nab 2nd. Motion carries.
