Magistrate Comments

 Long – has received calls on HWY 1492, Kings Ridge, Mound Hill and HWY 55 regarding trees needing to be trimmed. Rob Miller stated on HWY 55 there are trees over the weight limit sign,

- so the semi-trucks are not able to see it. Magistrate Long also stated he has received complaints about trees needing trimmed on Hampton Lane.
- Cable HWY 467 needs trees trimmed and also the slip-on HWY 227 needs attention. Thanked Tony Crutcher for his willingness to work with other departments.
- Nab
 - Thanks to the Road Department, there is such contrast between the County Roads and State HWYs. Magistrate Nab will be meeting with the Road Department Supervisor to discuss the roads in District 3.
 - Questioned if there is any update on the status of the Pickleball courts and the lighting on the courts. Judge Wilhoite stated JP Dale had no update and he has received a few quotes for the lighting. Scott proposed to get rid of the tree post and do perimeter lighting. Judge Wilhoite stated he has reached out for donations for the lighting.
 - Asked for feedback from the court regarding the road adoption ordinance. Magistrate
 Cable suggested discussing it more during the work session.
