A regular meeting of the Carroll County Fiscal Court was held on Tuesday, March 28, 2023. Members present were Judge Executive David Wilhoite, Magistrate Benjie Long, Magistrate Clay Cable and County Attorney Nick Marsh. Magistrate Scott Nab was absent. Judge Wilhoite called the meeting to order at 9 a.m.

West Side Fire Department

West Side Fire Chief Nathan Carter is requesting Carroll County Fiscal Court to purchase a hydraulic cutter and rescue high pressure air bag kit, both are currently very outdated. Chief Nathan Carter is also requesting the West Side Fire dues be added onto the property tax bills for that district. It would still be optional to pay however it would eliminate the cost of mailing the postcards to the district. Magistrate Cable made a motion to purchase the equipment requested for West Side Fire Department. Magistrate Long 2nd. All in favor. Motion carries.

All vehicles have been paid for and transferred, the ambulances are still needing to be picked up.
