The regular meeting of the Carroll County Fiscal Court was held Tuesday, August 12, 2014. Members present were County Judge/Executive Harold "Shorty" Tomlinson, Magistrate Floyd Bowling, Magistrate Dean Miller, Magistrate Mark Bates and County Attorney Nick Marsh.

Call to Order

Judge Tomlinson called the meeting to order at 9 a.m., observing a moment of silence for members of our military and those less fortunate.

Approve Minutes

Magistrate Bates made a motion to approve the minutes of the July 22, 2014 meeting. Magistrate Miller 2nd. All in favor. Motion carries.

Magistrate Miller made a motion to approve the attached list of budget transfers. Magistrate Bowling 2nd. All in favor. Motion carries.

Waste Tire Report

The 8 counties in northern KY region collected 103538 tires, with 11267 from Carroll County.

Waste Tire Grant

Magistrate Miller made a motion to allow the County Judge to sign all paperwork necessary to apply for the Waste Tire Grant. Magistrate Bowling 2^{nd} . All in favor. Motion carries.

Judge Tomlinson presented an amendment to the policy manual for Rescue Squad officers and members that no lights or sirens may be used on personal vehicles when responding to a call and all traffic laws must be obeyed. Magistrate Bates made a motion to approve the policy amendment. Magistrate Bowling 2nd. All in favor. Motion carries.

Hall of Justice/ AOC

Judge Tomlinson will be contacting AOC regarding parking issues at the Hall of Justice and acquiring property to expand the parking lot. No action taken.

Tax Rates

Tax rates need to be set and turned into County Clerk's office as soon as possible. Judge Tomlinson recommended the motor vehicle/watercraft rates be left the same as last year. Magistrate Miller made the motion to leave the Motor Vehicle and Watercraft Property tax rate the same for 2015 at 15.300 cents per \$100. Magistrate Bowling 2^{nd} . All in favor. Motion carries.

Senior Van

Judge Tomlinson has been getting information about purchasing a van for the senior center on state contract. He has been unable to locate a 2014 model and the 2015 model prices have not been set yet. He will continue to work on it. No action taken.

College Fundraising Report

Currently \$1.8 million has been raised for the project and presentations are scheduled in other counties. No action taken.

Road Supervisor Appointment

Judge Tomlinson made a motion to appoint Gene Clayton as the new road supervisor for a term to expire December 2014. Magistrate Miller 2nd. All in favor. Motion carries.

Road Report

- Longer delays are expected on I 71 this week due to road work.
- The work Eaton has done on the Rural Secondary roads looks good.
- A letter requesting tree and vegetation removal on state roadways has been sent, but no response has been received yet.
- A letter regarding the need for a turn arrow traffic signal at the high school has been sent. The signal has already been installed.

No action taken.

County Judge's Comments

- KY Utilities recently did a community service day and did a lot of work at Camp Kysoc. Scott's donated mulch and Ricks Glass donated service and materials to replace broken glass at the camp. Their efforts are very much appreciated.
- Feed the Children will be delivering donated food on Thursday at CCHS, volunteers are needed.
- There seems to be a spike in the homeless issues in the community over the last couple of months. The crisis center and ministerial association are doing what they can to help.
- The Local Issues Conference is coming up. A project submitted by our region is being considered for a Spirit of Kentucky Award.

County Attorney Comments

Judge Tomlinson asked the County Attorney to draft a letter to the contractor working on the pool. The court has not been satisfied with their work. No action taken.
