COVID-19 Vaccination Policy

The federal government is requiring that all employers that have over 100 employees have a COVID-19 Vaccination Policy in place by February 9. Several complaints have been received regarding Hwy 36 West. Judge Tomlinson urged everyone to contact their general assembly members regarding the condition of state roads.
