Call to Order

- A tree fell at KYSOC and caused some roof damages. Judge Tomlinson has met with Sherry Whisman with State Parks about the issue. The damages and removal of tree may be covered under the state park's insurance policy.
- Judge Tomlinson met with an ADD planner regarding the Trails project and she will be helping get things back on track.

Flu Outbreak

Three Rivers District Health Department has given over 4000 flu shots this season. No action taken.

Economic Development Cabinet

The I-71 Group recently did a presentation for the Economic Development Cabinet. Judge Tomlinson gave the magistrates copies of business cards from the meeting for contact information. No action taken

NAS Bonds – 1st Reading

Mary Jean Riley and Bill Skees with NAS were in attendance to ask the court for a first reading of an ordinance authorizing the issuance of up to \$36,170,000 principal amount of County of Carroll , Kentucky Solid Waste Disposal Revenue Refunding Bonds. Magistrate Bates made a motion to have the first reading of the ordinance. Magistrate Bowling 2^{nd} . All in favor. Motion carries.

County Attorney Nick Marsh read the ordinance. The second reading is scheduled for February 8.

County and State Road Report
