

Broadband Update

There will be an updated data map done based on the results from the broadband test run that the State of Kentucky provided.

Solar Projects

There are solar farms in Eastern Kentucky which are farms leasing acreage to companies for solar panel placement. Judge Tomlinson urges people to be cautious if considering leasing their land for solar farms.

County Roads

The road crew has been busy moving debris and cutting trees that have fell over the roadways during our last storm. With all of the recent rainfall, there are several culverts stopped up that the road department will be cleaning out. Judge Tomlinson had a call from a citizen on Mill Creek stating the water was in his mail box after the storms. The problem with Mill Creek, with all of the Federal regulations, we cannot do work on the creek without permits that are difficult to obtain. Also, the bridge on Buffalo might have to have a reduced weight.

Judges' Comments

- Federal funding, still haven't received. Still urging counties to proceed with a lot of caution. CCWD needs a water tank and Carrollton Utilities would like to prepare the property they own on Greens Bottom for future growth. The money has to be obligated by 2024 and spent by 2026.
- Department of Fish and Wildlife said there was 250,000 kids that attended the camp.
- Senior Centers in KY served 4.5 million meals in the last 15 months.
- Data Mapping for broadband should be done by July.

County Attorney Comments

Magistrate Comments

Graham- Appreciated the judge sending pictures to the Transportation Cabinet on the intersection on HWY 227 and HWY 42 where the concrete and the asphalt meet. Also, in the same area there has been complaints of jake braking, but all signs for that from there to Ghent have been stolen and need to be replaced.

Bowling – Ditching on Greens Bottom. Judge stated he called the Senator regrading KY River Bridge.

Bates – was asked to get a valve for County Pool, so he will be ordering that.

Judge Tomlinson informed the court that JP Dale had mentioned that Trimble County Parks and Rec needs a few bleachers, and with the ones piled up at the County Park, he felt it would be a good idea to donate some. All in favor.

Sheriff Gosser

Sheriff Gosser did not see an increase in the bailiff line after the second first reading of the budget.

Judge Tomlinson informed it would be changed July 1. Magistrate Bates asked what the reimbursement rate from the AOC was for bailiffs. Sheriff Gosser stated \$9/hour was reimbursed from the AOC.
