- Milling and new concrete work is being done at the intersection of Hwy 227 and 42.
- The interstate ramps at exit 44 are being repaved and will be closed to traffic overnight.
- Locust Bridge project has been extended to 07/03. The beams are to be delivered this week.
- Park Avenue/227 – the center hump is to be removed and a turn lane added at the high school. Bids have not been let but hoping for completion prior to school starting.
- Sanders RR Crossing is almost complete.
- Buffalo Bridge – Luhn and Oak Construction were awarded the bid and construction should begin any day. The bridge will be closed for 60 days.
- The road supervisor will be making recommendations for county road upgrades.

Law enforcement officers have been advised to site pet owners that do not keep their pets contained to their property or on a leash.
