Also, the District 6 office is ready to hire a consultant to begin the feasibility study on the project.

State Road Report

County Officials are still not happy with the roadside mowing on state roads recently. There is one document that still needs to be received before the Hwy 36 bridge can be let.

County Judge Comments

Judge Tomlinson updated the court on his recent NARC Conference in Florida.

Judge Tomlinson signed the attached Annual Rescue Squad Executive Order.

Rescue Squad is looking into the possibility of purchasing a camera for water recovery emergencies. More info to follow.

There is over \$500 left in the fourth quarter for the Crisis Center Funding. Court members agreed to use a portion of that money to purchase fans to be distributed to those in extreme need.

Kanute Rarey, CEO Carroll County Memorial Hospital, was on hand to recognize Jim Monk with a plaque for 22 years of service on the Hospital Board.
