County Road Report

State Road Report

The state highway department is currently working to repair the slip on Whites Run.

County Judge Comments

The Summer Youth Program guidelines have changed this year. Participating counties would have to pay an administration fee of \$200 per employee in order to participate. Also some unemployed younger parents can participate. The court agreed to move forward.

The Census 2010 is showing a completion percentage of 75% for Carroll County. The national average is 72%, and the state average is 75%.

The unemployment rate for Carroll County for February was 15.7%. March was 14.8%.

There are grants available for Fire Departments. All the local Fire Departments have been notified of the opportunity.

Magistrate Bowling made a motion to install a fire hydrant on Lock Road. Magistrate Bates 2nd. All in favor. Motion carries.
