A special meeting of the Carroll County Fiscal Court was held on Tuesday, October 30, 2018, at 4:00 P.M. at Camp KYSOC, Easterday Road, Carrollton, Kentucky 41008. The meeting was properly announced, advertised and posted and an agenda was prepared in advance. Members present were Judge Executive Bobby Lee Westrick, Magistrate Floyd Bowling, Magistrate Kerry Graham and County Attorney Nicholas A. Marsh. Magistrate Mark Bates was not in attendance. The meeting was called to order and a quorum was declared by Judge Westrick at 4:00 p.m., EST.

Declaration of Items as Surplus

Recommendation was made by Carroll County Parks & Recreation Director JP Dale to declare the following items as surplus inasmuch as said items were no longer of use or value to Carroll County:
