## ORDINANCE NO. 16-0510B

# AN ORDINANCE OF CARROLL COUNTY, KENTUCKY, AMENDING THE SECTION OF THE CODE OF ORDINANCES, AUTHORIZING AND REGULATING THE OPERATION OF GOLF CARTS & ALL-TERRIAN VEHICHLES WITHIN CARROLL COUNTY

WHEREAS, Carroll County Fiscal Court adopted Ordinance No. 2016-0322, which authorized and regulated the operation of golf carts and all-terrain vehicles within Carroll County, Kentucky; and

WHEREAS, it has been recommended that said Ordinance No. 2016-0322 be amended; and,

WHEREAS, the Carroll County Fiscal Court desires to amend said Ordinance No. 2016-0322, according to the terms and provisions of this Ordinance.

NOW THEREFORE, BE IT ORDAINED BY THE COUNTY THE COUNTY OF CARROLL, KENTUCKY AS FOLLOWS:

<u>Section 1</u>; The Carroll County Fiscal Court in Carrollton, Kentucky, docs hereby authorize and regulate the operation of Golf Carts and All-Terrain Vehicles on the public roadways specified herein that are under its jurisdiction and pursuant to the terms and conditions as set forth herein.

#### **Section 2: Definitions**

- 1. The Golf Carts authorized and regulated by this ordinance are those as defined in KRS 189.286 (1) (a).
- 2. The all-terrain vehicles authorized and regulated by this ordinance are those as defined in KRS 189.010(24).
- 3. The public roadways under the jurisdiction of the County of Carroll upon which a Golf Cart & ATV may be operated are as follows:

#### **SECTION 3 CONDITIONS OF OPERATION**

Any Golf Cart or all-terrain vehicle operated on a designated public roadway pursuant to this Ordinance shall, prior to said operation:

- 1. Be issued a permit for the golf cart or all-terrain vehicle by the Carroll County Fiscal Court. The fee for said permit shall be \$10.00. Said permit shall be renewed annually in <u>July April</u> of each year.
- 2. Display a sticker or permit that identifies that the golf cart or all-terrain vehicle is allowed to be operated on specified roadways within Carroll County, and
- 3. Be inspected annually by a certified inspector designated by the Carroll County Sheriff and certified through the Department of Vehicle Registration pursuant to KRS 186A.115. The Sheriff shall be authorized to collect any fee for inspection that he otherwise would charge pursuant to KRS Chapter 189 for vehicle inspections. The Sheriff's inspection shall be limited to insuring compliance with this Ordinance and applicable provisions of the Kentucky revised Statutes. The Sheriff's Inspection shall not constitute or warranty as to the mechanical fitness or safeness of said vehicle.

### **SECTION 4: REGULATIONS FOR OPERATION**

A person may operate a golf cart or all-terrain vehicle on the specified public roadways within the said County of Carroll if, and only if, the following conditions are complied with:

- 1. The posted speed limit of the portion of the designated public roadway upon which the golf cart or all-terrain vehicle is being operation is thirty-five (35) miles per hour or less.
- 2. The operator of the golf cart or all-terrain vehicle does not cross a roadway at an intersection where the roadway being crossed has a posted speed limit of more than thirty-five (35) miles per hour.
- 3. The operator has a valid operator's license in his or her possession.
- 4. The golf cart or all-terrain vehicle shall only be operated between sunrise and sunset; and
- 5. The golf cart or all-terrain vehicle shall display a slow moving vehicle emblem in compliance with KRS 189.820.
- 6. Any all-terrain vehicle shall equipped with at least one (1) headlight and two (2) tail-lights, and said lights shall be illuminated at all times the vehicle is in operation pursuant to KRS 189.515(6)(f).
- 7. A golf cart or all-terrain vehicle operating on specified public roadway under this Ordinance shall be insured in compliance with KRS 304.39-080 by the owner operator, and the proof of insurance shall be inside the golf cart or all-terrain vehicle at all times of operation on public roadway.
- 8. Any operator of a golf cart or all-terrain vehicle shall comply with all other terms and provisions of KRS 189.286, other Kentucky statutes and motor-vehicle laws, and ordinances of Carroll County.

**SECTION 5:** This Ordinance shall be effective upon its adoption and approval according to law.

**SECTION 6:** All Ordinances or parts of any Ordinance in conflict herewith to the extent of such conflict, if any are hereby repealed.
